## Declaration of Independence

Dated: 1 September 2014

This Declaration of Independence is a formal and symbolic act of asserting our sovereignty and autonomy of our new free state, the Republic of Agiara, to assist the humanity with humanitarian project and to support needed people with finance and aid projects.

We, the people of the Republic of Agiara, in full exercise of our natural rights and in recognition of our responsibility to future generations, hereby declare our independence and sovereignty. We do so in accordance with the principles of international law, human dignity, and the inalienable right of all peoples to self-determination.

We hold that all people are entitled to life, liberty, and the pursuit of happiness, free from external domination, and with the right to establish a government that is by and for the people. In pursuit of this ideal, we hereby declare the Republic of Agiara to be a sovereign and independent state, committed to the promotion of peace, justice, and freedom.

The island upon which the Republic of Agiara now stands was, prior to our founding, uninhabited and unclaimed by any nation or entity. Recognized as *terra nullius* under international law, this land provided an opportunity for the establishment of a free and just society, governed by the rule of law and principles rooted in respect for nature and humanity.

On this basis, and in accordance with the inherent right of self-determination, we, the people of Agiara, declare our island to be a sovereign republic, free from external control or domination.

In declaring our independence, we assert that the Republic of Agiara has met all conditions required for statehood under international law, including:

**A defined territory:** Our island is geographically defined and permanently inhabited.

**A permanent population:** We are a community bound by shared values and a common vision for the future.

**A government:** We have established a constitutional government, based on the principles of democracy, human rights, and the rule of law.

**The capacity to enter relations with other states:** We are prepared to engage in peaceful and productive relations with the international community.

Therefore, we, the undersigned, on behalf of the people of Agiara, do solemnly declare that the Republic of Agiara is, and by right ought to be, a free and independent state. We renounce any external claims of sovereignty over our land and affirm that we possess full authority to govern ourselves, to form alliances, to establish trade, and to engage in all other actions and duties of a sovereign nation.

In making this declaration, we pledge our commitment to uphold the values of democracy, justice, and freedom, and to work in cooperation with all nations and peoples for the advancement of peace and human dignity.

The Republic of Agiara is founded on the principle of peaceful coexistence and mutual respect. We are committed to the pursuit of sustainable development, the protection of our natural environment, and the promotion of global cooperation in the face of shared challenges such as climate change and international security.

We pledge to uphold the United Nations Charter and to work in partnership with the international community to advance the common good.

With this declaration, we assume our rightful place among the sovereign nations of the world. We call upon all free peoples and nations to recognize the Republic of Agiara and to welcome us into the community of nations as an equal partner, dedicated to the pursuit of peace, justice, and prosperity for all.
